

# **Privacy Practices Policy for Arms Stretched Wide (ASW)**

ASW values the privacy of our supporters, donors, staff, volunteers, and clients. This Privacy Practices Policy explains how we collect, use, protect, and disclose personal information in accordance with applicable privacy laws and regulations. We are committed to ensuring your personal information is handled carefully and respectfully.

## 1. Information We Collect

We may collect personal information from individuals in the following ways:

- **Donors and Supporters:** Name, address, email address, phone number, donation history, and payment information.
- Volunteers: Name, contact details, skills, experience, and emergency contact information.
- **Staff:** Personal contact details, employment records, and financial information necessary for payroll and benefits administration.
- **Clients (if applicable):** Name, contact information, and any other relevant details needed to provide services.

We collect this information **only** with your **consent** or when it is required for our **legitimate purposes**.

## 2. How We Use Your Information

- Legal Requirements: We may disclose personal information when required by law, such as in response to a subpoena or court order.
- **Consent:** We may share your information **with your written consent** or at your written direction.

## 5. Your Rights and Choices

As an individual whose personal information we collect, you have the right to:

- Access: Request a copy of the personal information we have about you.
- Correct: Ask us to update or correct any inaccurate or incomplete information.
